



# D19 Re-alignment Needed for 2023-2024

Hi Jesse,

Thank you for all of your guidance on fixing our District 19's non-compliant status in 2023-2024 where 2 Areas, i.e., Area 21 and Area 41 have only 2 active clubs. We would appreciate it if you could make changes in the system for us as I do not have access to the alignment function in the District Central anymore. We would appreciate it if you could give us an extract after the change.

**Problem:**

Each Division to have at least 3 Areas, Each Area to have at least 3 active clubs, ideally 4-6 clubs. **Area 21 and 41 had only 2 active clubs.**

The proposed District alignment for 2024-2025 was no change and approved by District Council on 4/27/24. The alignment report was not submitted to WHQ no later than July 15<sup>th</sup>.

**Solution:**

Carrie Dostal, Past District 19 Director, assumed the role of Alignment Committee Chair. She and her committee that consists of Division Directors came up with the proposal below. **Re-establish Area 21 with the following clubs:**

**Action Needed:**

Please reassign 2061 Top O Morning Toastmasters Club and 2670 Siouxland Ciceros Club back to Area 21 as they are currently unassigned.  
Please move 386 Shiboletth from Area 22 to Area 21.  
Please reassign Chance Bernstrauch as Area 21 Director.

**Division X**

**Re-establish Area 41 with the following clubs:**

**Action Needed:**

Please reassign 3250 Collins Aerospeakers and 3515 Sunrise Marion Toastmasters Club back to Area 4 as they are currently unassigned.  
Please move 605919 1100 Toastmasters from Area 63 to Area 41. Otherwise leave alone.  
Please reassign Serena Collins as Area 41 director.

**Division Y**

**Dissolve Area 63 and the number of Areas in Division Y to decrease from 5 to 4.**

Please reassign Colleen Lange from Area 63 Director to Area 61 Director. – Saeko made this change in the District Central Leader Assignment function 7/25/24.

Area 63:
